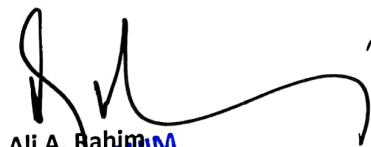

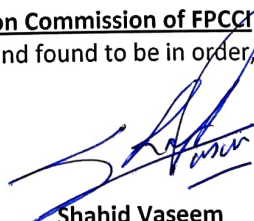

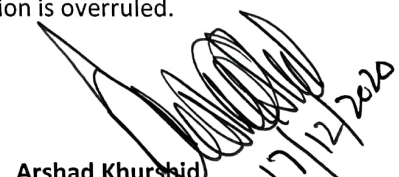
The Chakwal CCI submitted the requisite documents by email regarding the status of their Trade License.
