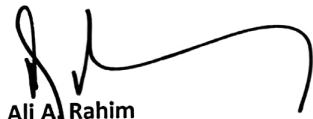

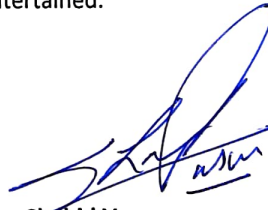
Objection filed by Mr. Tariq Haleem Candidate for President against the nominations of Zhob Chamber of Commerce & Industry, Balochistan (copy attached).
