He is not member of any Trade Body, the objection cannot be entertained. He may be appeal to Election Commission of FPCCI.

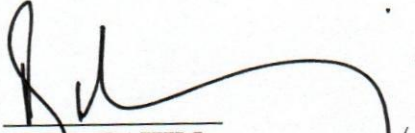

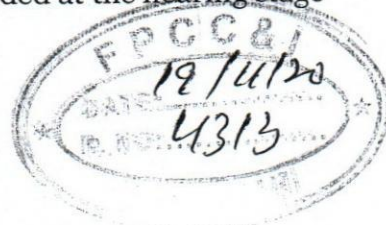

1. Mr. Muhammad Jami Ahmed, executive member of Air Cargo Agent Association submitted objection against the nomination submitted by the aforementioned Association on grounds that the elections of the aforementioned association are disputed along with the fact that the Association is in non-compliance with number of the statutory requirements set under Trade Organization Act 2013 and Trade Organization Rules 2013 and the Directorate General of the Trade Organization has taken cognizance on this.
2.
