As per Clause No. 15(a) of the TOR 2013, the member has not completed two years of valid membership of the trade organization as on the date of announcement of election schedule by the Executive Committee of the Trade organization.

Reply by the Respondent Trade Body

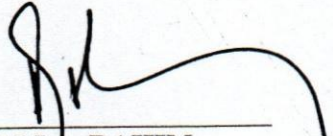
Women CCI Korangi highlights that Section 10(3) of the TOA-2013 as under:-

"A chamber or an association which is a member of the FPCCI shall be eligible to vote in the election of Office bearers and committee of the FPCCI on completion of two years of grant of license."

The intention of the legislature was that, in order for any entity to qualify or become eligible as a voter in the FPCCI election they should complete 2 years of membership before the final list of voters for an election are finalized. The right of voting accrues upon completion of 2 years before finalizing the final list of voters scheduled to be public on 8th December 2020
