Decision of the Members of the Election Commission of FPCCI:

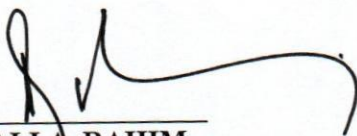
While concluding the matter the Members of the Election Commission of FPCCI decided as under:

After lapse of meeting time he informed on phone that he was not able to attend hearing due to illness therefore requested to fix another hearing on Monday, 23rd November, 2020. His request was accepted by the Election Commission on humanitarian ground and he deputed representatives who appeared before the Election Commission on 23.11.2020 at 11. 30 a.m.

After hearing the arguments of his representatives, the Election Commission maintained the decision of the Secretary General, FPCCI.
